On behalf of Kokusai Cable ship Co. Ltd (KCS), the UJ Consortium is pleased to introduce a new UJ/UC Fusion Splicer UJS-S100R.

The UJ/UC fusion splicer and accessories are renewed to conform to the RoHS (Restriction of the use of certain Hazardous Substances in electrical and electronic equipment) Directive (2002/95/EC) by the EU.

As the result of renewal, the equipment and tools will be changed to the lead-free equipment and tools as follows.
