Unauthorized components use on UJC equipment and tool

Requests for assistance have been received relating to the molding equipment and the components therein. It has been found that the majority of these requests have been generated by the user's using incorrect components or components that have not been sourced from a UJC member, and therefore that can not be considered to be fit for purpose with this Equipment.

The UJC would like all UJ users to be reminded that if any UJC equipment and tools is suspected to being faulty, they should contact their UJC vendor prior to attempting modification or repairing using **non** Original Equipment Manufacturer (OEM) or other "off the shelf" components.

Regrettably support cannot be provided for Equipment that has been modified or reworked using **non** OEM supplied components, as this invalidates any warranty on the equipment as well as may jeopardize the quality of the work being performed.
