### ASN Screen Molding Termination

The UJC wishes to advise all its customers of the changes to the ASN Screen Molding Termination procedure for OALC2, OALC6, URC3 & NL LWS/LWP cables. The previous procedure has been discontinued in favor of the Heat shrink termination procedure and the following end specific kits for ASN screened or sheathed cables have been superseded by the end specific kits for the **ASN LW** cable plus the new Heat shrink Termination kit, **KIT241AA**, for example please see below :

The impacts of the introduction of the new kits are:

- KIT217AA, the Screen Molded Termination kit is removed.
- The tools and equipment associated with screen Molded Termination are discontinued.
- The new Heat shrink Termination kit, KIT241AA, replaces KIT212AA, KIT212CC and KIT222AA.
- All screen termination components are contained in KIT241AA.
- For H<sub>2</sub>S environment, in addition of KIT241AA, the Hydrogen Sulphide Protection KIT 221AA shall be used.

The transition between the old and new end specific kits will take place on **1<sup>st</sup> July 2006**.
